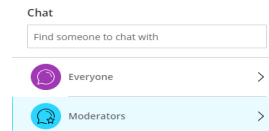

Change regarding 30 additional questions

Starting in 2020, CPRD will no longer be able to support the option of adding 30 additional questions to the Illinois Youth Survey (IYS).



Rationale

Because the additional questions are answered and submitted as part of the IYS, which is approved for parent notification, the IRB must approve all additional questions.

Creating a separate IRB review process for additional questions falls outside of our purview.

Questions about sensitive topics without proper signed consent have the potential to put the survey's IRB approval in jeopardy.



What now?

Focus on the two main goals of the IYS

1. To supply local data to schools and school districts throughout Illinois by creating IYS Frequency Reports and sharing them with schools/districts that participate.
2. To provide health and social indicators for the state of Illinois (i.e., a representative sample of 8th, 10th, and 12th graders) that can be used for examining trends statewide and in four community types.



Continue to keep pace with current trends

In research, practice, and prevention in various content areas:

1. Substance use behaviors, attitudes, and perceptions
2. Family support and rules about alcohol use
3. Feelings about school
4. Violence
5. Bullying
6. Depression
7. Health, fitness, and nutrition



Continue to deliver

1. Data at no cost
2. Timely data collection
3. Benchmark data



Continue to provide

- Frequency reports by grade level for all variables for school/district/counties/community areas
- Technical assistance to schools and providers regarding survey administration and data usage.
- IYS administration continues to be a requirement for IDHS SUPR grants

Alternatives for gathering local data

1. Review current IYS questions and consider whether an existing question/set of questions would meet your needs
2. Use other data variables as proxy
3. Conduct your own survey and go through your own IRB



Use current IYS questions

Consider whether funders/stakeholders agree to use current IYS questions

- IYS questions have been vetted by experts in their fields
- IYS questions are tailored to the age level of respondents, with the high school form covering a broader set



Use proxy data

Do away with exact questions and use other data sources for proxy variables such as:

- 5 essentials – school supports
- School academic data, counselors/SSW, school nurses data
- District data
- Coalitions' data
- Health clinics data
- Other partners data



Conduct your own survey

- Go through your agency's Institutional Review Board (IRB)
- Build into School or District Surveys
 - Ask district offices for resources
- Build into your programming
 - YPE, Campaigns (pre- post surveys)
- Set up your own survey as a project
 - Ask a volunteer/intern
 - Survey Monkey, Remark Survey, Qualtrics



How does this affect your role?

IYS will continue to provide outcome data for your SUPR funded grants, and thus funded providers continue to be IYS ambassadors.

You will continue to receive training and technical assistance on IYS recruitment and data utilization.
